Who Can Apply?

You may be eligible if your organisation is a:

- Not-for-profit organisation
- Social enterprise
- Non-distributing co-operative

Your project must directly address food insecurity and be delivered within Victoria.

What We're Looking For

We're looking for projects that create meaningful, measurable impact by improving food access and strengthening the systems behind it.

Projects should align to at least one focus area:

- Build Capacity
- New Ideas & Programs
- Scaling Proven Models
- Organisational Sustainability

About The Big Difference

At Chobani Australia, we believe food should be a source of connection, nourishment, and dignity — not stress. But right now, too many people across Victoria are going without the food they need.

The Big Difference is our grants program backing practical, community-led projects that address food insecurity across Victoria. As a **food maker** built on **Good Food For All**, we're investing **\$150,000** in 2026 to support work that improves food access and strengthens the systems behind it — from tools and infrastructure to scalable models and long-term sustainability.

We know social purpose organisations are already on the ground doing impactful work with limited resources. That's why this program exists: to back local changemakers with targeted funding to help organisations grow, test new approaches, scale what works, and build long-term sustainability.

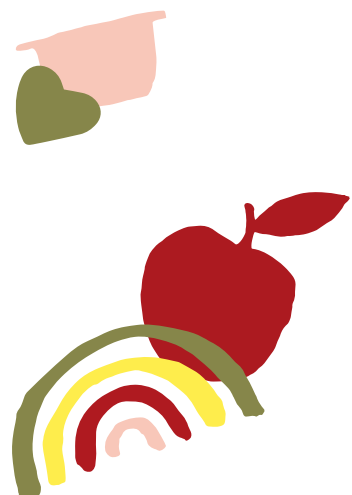

What Are We Looking For?

Food insecurity is a growing challenge across Australia — but there are incredible organisations already taking action in their communities. Through The Big Difference, we're looking to support social purpose organisations working on projects that directly address food insecurity in meaningful, measurable ways.

You don't need to be an organisation focused on emergency food relief to apply. What matters most is that the project you're seeking funding for **directly addresses food insecurity** — by improving food access and strengthening the systems that support it (for example: capacity, tools, infrastructure, new approaches, scalable models, and long-term sustainability).

We're looking for organisations that can demonstrate:

- Clear commitment to addressing food insecurity
- Strong understanding of the communities they serve
- Ability to deliver the proposed project and sustain its impact
- Capacity to track and report outcomes.

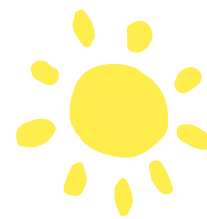
Your project must align with at least one of the following focus areas:

- **Build Capacity:** Strengthening systems, tools, training or ways of working that help your organisation better address food insecurity.
- **New Ideas and Programs:** Testing a new idea or approach, piloting new work, or expanding an early-stage initiative that your organisation hasn't tried before.
- **Scaling Proven Models:** Growing or replicating a program that is already working well and demonstrating impact.
- **Organisational Sustainability:** Creating sustainable improvements that help your organisation thrive long term.

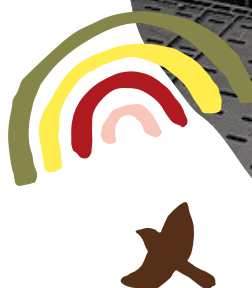
We actively encourage Aboriginal and Torres Strait Islander-led organisations, and programs that address food security in Aboriginal and Torres Strait Islander communities, to apply.

Food Insecurity (Definition)

The Food and Agriculture Organisation of the United Nations defines food insecurity as a lack of regular access to enough safe and nutritious food for healthy growth, development, and an active life. This may be due to food being unavailable or a lack of resources to obtain it. Food insecurity can range in severity from mild to severe.

Who Is Eligible?

Organisations are eligible to apply if they are a:

- Not-for-profit entity – charitable organisation
- Not-for-profit entity - incorporated association
- Not-for-profit public company limited by guarantee
- A co-operative operating on a not-for-profit basis
- Social enterprise

Eligibility for Social Enterprises

Your social enterprise is eligible if:

- Your enterprise directly addresses food insecurity
- You reinvest more than 50% of profits from goods or services back into your core mission
- Profits are **not** distributed to private shareholders
- Profits are **not** donated to a separate charity or unrelated organisation
- You are **not** applying on behalf of another not-for-profit

Eligibility for Co-operatives

Only non-distributing co-operatives are eligible to apply.

To be considered, your co-operative must:

- Operate as a not-for-profit organisation
- Be a non-distributing co-operative, meaning profits must further your co-operative's purpose and shares are not issued to members
- Demonstrate that your work addresses food insecurity in the community
- Be registered as a co-operative under the National Co-Operative Law

Organisations must also:

- Deliver the entirety of the project within **Victoria** (the organisation does not need to be registered or located in Victoria),
- Hold a valid Australian Business Number (ABN) — with correct, up-to-date information on the ABN Register <https://abr.business.gov.au/Search/Advanced>
- Have a relevant Australian bank account in the organisation's name
- Have in place, an elected and identifiable committee or similar group clearly responsible for managing the organisation.

Who Is Not Eligible?

We're passionate about supporting grassroots organisations, but we're unable to fund:

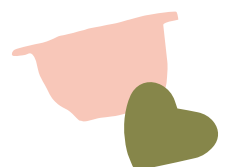
- Individuals
- Sole traders
- Government institutions
- Unincorporated associations
- Educational facilities or institutions (e.g. schools, universities, early learning centres)
- Hospitals
- Sporting organisations.
- Previous Chobani The Big Difference recipients

The program is structured to make grants directly to successful organisations and therefore auspice arrangements will not be considered.

What Projects Won't We Support?

To ensure we're backing sustainable, community-driven solutions, we won't fund projects that:

- Involve the direct purchase of Chobani products,
- Fund the direct purchase of food (our focus is on long-term solutions, not emergency food relief),
- Don't have evidence of secured funding to cover the full project cost. If Chobani's grant won't cover the total amount, applicants must show confirmed support for the remaining funds (e.g., requesting \$20k toward a \$75k project with no other secured funding may not be eligible),
- Discriminate against or exclude members of the community,
- Involve political, religious, gambling, weaponry, or military-related activities,
- Include alcohol, drug, or tobacco use,
- Are considered high-risk activities (e.g., extreme sports),
- Are general donations without a specific project focus,
- Focus primarily on one-off fundraising or public events,
- **Primarily fund** staff wages or operational overheads (e.g., salaries or headcount),
- Are designed solely for academic research.

Funding Available

We are offering three to five grants across three funding categories:

- up to **\$50,000**,
- up to **\$30,000**,
- up to **\$20,000**.

We encourage organisations to apply for the funding level that best suits their project. **Big or small — what matters most is that your project is meaningful, achievable, and aligned with our goal of addressing food insecurity.**

Only one application per organisation will be considered.

Organisations will need to demonstrate they will have secured the full funding amount to complete their project, including any additional funding sources if the Chobani grant does not cover the full project cost.

Project Timeline

Funded projects must:

- Commence by **February 2027**, and
- Be completed by **December 2027**.

Stage 1: The Big Pitch

Applications open Tuesday 14 July 2026 (9:00am AEST) and close Tuesday 25 August 2026 (5:00pm AEST).

In Stage 1, you'll submit a short video (up to **2 minutes**) introducing your organisation and your project.

To help us understand your organisation and project, you may include:

- A brief overview of your organisation and mission
- Who you support and the impact you're making today
- The project you're seeking funding for — why it's needed and how the grant will be used [
- The food insecurity challenge you're addressing and why your solution is the right fit
- Your intended impact and how you'll measure success
- How the project aligns to at least one focus area:
Build Capacity, New Ideas & Programs, Scaling Proven Models, Organisational Sustainability

Get creative!

This is your chance to bring your project to life and show us how we can be part of your journey. But remember: the most important thing is that you clearly show the need in your community and how your organisation is helping to tackle food insecurity.

To accompany your video, you'll answer a few short questions online, covering:

- Contact details,
- Organisation details,
- Director details,
- Overview of your impact and mission,
- Short description of your project,
- How your project addresses food insecurity.

Video requirements:

- Film in landscape mode,
- Ensure clear audio,
- File must be in an accepted format:
 - MP4
 - AVI (DivX, Xvid)
 - WMV (Windows Media Video)
 - FLV (Flash Video)
 - MPEG (MPEG-4)
- Alternatively, upload to YouTube or Vimeo and provide a link.

Stage 2: The Shortlist

Wednesday 16 September 2026 - Tuesday 6 October 2026

Shortlisted applicants will complete a more detailed questionnaire to deepen our understanding of their impact and project.

Note: Shortlisted applicants (Stage 2) will need to demonstrate how their project can be completed by **December 2027**.

Stage 3: The Interview

From week commencing 2 November 2026

Shortlisted organisations will be invited to attend an interview with Chobani's Social Impact Team. This interview will take place via Teams and will be your final opportunity to help us get to know you and your project.

The Finale

Successful applicants will be notified in **November 2026**.

Assessment and Due Diligence

Chobani will review applications at each stage and will engage with Goodstack to assist with due diligence for those in the final round.

Goodstack will assist with the program's assessment and validation. You may be contacted by them to provide details, including your organisation's bank information, for validation.

Successful Applicants – Staying Connected

Our goal is to create real, lasting change — and we'd love to stay connected to celebrate your progress.

After your project kicks off, we'll check in along the way:

- **3 months in, 6 months in, 12 months or**
- **Upon completion of your project**

At each milestone, you'll complete a short impact questionnaire, giving you the chance to share your wins, learnings, and challenges. This helps us celebrate your achievements — and learn how we can keep making a difference together.

Grant Funds Distribution

Successful applicants can expect to receive a Funding Agreement for your organisation's review and completion. Grant funds will be electronically transferred upon signing a Funding Agreement with Chobani.

FAQs

About Applying

Who can apply?

Not-for-profit organisations, non-distributing co-operatives and social enterprises are eligible to apply — as long as the project you're applying for **directly addresses food insecurity** and will be delivered within Victoria.

You don't need to be solely focused on emergency food relief to apply. What matters is that your project contributes meaningfully to addressing food insecurity — including by improving food access and strengthening the systems behind it (for example: capacity, tools, infrastructure, new approaches, scalable models, and long-term sustainability).

Previous Chobani The Big Difference grant recipients are not eligible.

Does our organisation need to be a registered charity?

Not necessarily. We welcome applications from charities, co-operatives, social enterprises, and other not-for-profit organisations. You must be able to provide appropriate documentation, have an active ABN, and demonstrate alignment with the program's purpose.

Can we apply through a third-party or use an auspice?

No. The program is designed to provide grants directly to the organisations delivering the work. Applications submitted through third-party or auspice arrangements will not be considered.

I'm a social enterprise – am I eligible to apply for funding?

Yes, your social enterprise is eligible if:

- Your enterprise directly addresses food insecurity
- You reinvest more than 50% of profits from goods or services back into your core mission
- Profits are not distributed to private shareholders
- Profits are not donated to a separate charity or unrelated organisation
- You are not applying on behalf of another not-for-profit.

I'm a co-operative, can I apply?

Only non-distributing co-operatives are eligible to apply. You must be able to demonstrate you are operating as a not-for-profit organisation (profits are reinvested to further the co-operative's purpose) and the project relates to addressing food insecurity. Co-operatives must also be registered under the National Co-Operative Law.

Can I apply if my organisation is based outside of Victoria?

Yes — as long as the entirety of the project activities and services are delivered within Victoria.

Can I apply for more than one project?

No — we ask that you focus your application on a single project that best aligns with our program goals.

This may be due to food being unavailable or a lack of resources to obtain it. Food insecurity can range in severity from mild to severe.

About the Projects

What kinds of projects will you fund?

We're interested in projects that go beyond short-term emergency food relief and contribute to lasting impact in addressing food insecurity. Your project must fit into at least one of these focus areas:

- Build Capacity (strengthen systems, tools, training or ways of working)
- New Ideas & Programs (test a new idea or pilot a new approach)
- Scaling Proven Models (expand or replicate a program already working well)
- Organisational Sustainability (sustainable improvements that help your organisation thrive long term)

What projects won't you fund?

We won't fund:

- Direct purchases of Chobani products,
- Direct purchases of food (our focus is on long-term solutions, not emergency food relief),
- Projects that do not have full funding secured, or where secure funding cannot be demonstrated,
- Projects that discriminate or exclude,
- Political, religious, gambling, weaponry or military-related activities,
- Projects involving alcohol, drug or tobacco use,
- High-risk activities,
- General donations,
- One-off fundraising events, or public events,
- Projects which primarily fund staff wages or operational overheads,
- Academic research.

How much funding is available?

We're allocating up to **\$150,000** in total, to be distributed among **three to five recipients**. Organisations can select the grant amount most relevant to their project needs, with funding allocated as follows:

- between **\$10,000** and **\$20,000**
- up to **\$30,000**
- up to **\$50,000**

The selected amount should align with a project that can be completed by **December 2027**.

Should I include GST in my requested funding amount?

Yes. Include relevant project costs inclusive of any GST, so we can fully consider the total funding required to implement the project or program.

When will funding be granted to successful organisations?

It is intended grant funds will be paid from **November 2026**, with projects completed by **December 2027**.

How do I apply?

You can film your BIG Pitch video on a smartphone, webcam or video camera.

Please ensure:

- Your video is shot in landscape mode and audio is clear before uploading,
- Your file is in an accepted format:
 - MP4
 - AVI (DivX, Xvid)
 - WMV (Windows Media Video)
 - FLV (Flash Video)
 - MPEG (MPEG-4)
- Alternatively, you can upload it to YouTube or Vimeo and provide the link.

Can I submit more than one BIG Pitch video?

No. We ask that each organisation submit one BIG Pitch video focused on a single project.

How will applications be assessed and awarded?

Applications will be reviewed and assessed at each stage to determine the final selection for Interview and subsequent funding by Chobani Australia.

How will I know if I am shortlisted?

You will receive email communications from Chobani. Will the full amount applied for be awarded if my application is successful?

It is possible that the grant amount may vary from the original application request.

Should that occur Chobani will contact you to ensure the proposed project is able to proceed with the revised grant amount.

If our application is successful, is there a formal acceptance process?

To accept a grant, Chobani will provide a Funding Agreement for your organisations review and completion.

How will our organisation receive the funds if our application is successful?

All successful organisation's bank accounts are validated as part of our processing.

Following the provision of your signed Funding Agreement, grants funds are electronically transferred into your organisation's bank account.

Will I receive feedback about my application?

We're unable to provide detailed feedback to every applicant.

After Funding

If successful, what are the reporting requirements?

We'll check in at various milestones after your project begins:

- 3 months in, 6 months in, and at 12 months or upon completion of your project

When do projects need to be completed by?

It is intended grant funds will be paid from November 2026, and projects completed by December 2027.

What support will be provided beyond funding?

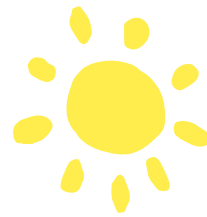

Application Terms and Conditions

1. These terms and conditions ("**Terms and Conditions**") apply to Chobani Pty Ltd's (ABN 53 096 731 467) ("**Chobani Australia**") grant program, The Big Difference as further detailed in the Guidelines ("**Grant Program**").
2. By submitting an Application you agree to be bound by these Terms and Conditions.
3. Capitalised terms in these Terms and Conditions have the following meanings:
 - (a) "**Applicant**" means the organisation that has applied for a Grant;
 - (b) "**Application**" means the content of the online form (including video submission) that an Applicant must complete and submit in order to be considered for the Grant;
 - (c) "**Eligibility Criteria**" means any eligibility criteria for Applicants set out in the Guidelines, as updated by Chobani Australia from time to time;
 - (d) "**Funding Agreement**" means a funding agreement between a successful Applicant and Chobani Australia on terms acceptable to Chobani Australia;
 - (e) "**Grant**" means any funds awarded to a successful Applicant under the Grant Program;
 - (f) "**Grant Webpage**" means the www.chobani.com.au/the-big-difference;
 - (g) "**Guidelines**" means the document titled "The Big Difference Guidelines" (available at www.chobani.com.au/the-big-difference) that sets out details of the Grant Program including Eligibility Criteria and the application, consideration and awarding process;
 - (h) "**Intellectual Property Rights**" means all patents, rights to inventions, copyright, trade marks, trade names and domain names, rights in goodwill, rights in confidential information and any other intellectual property rights, whether registered or unregistered and including all applications for, and renewals or extension of, such rights and similar rights which subsist now or in future anywhere in the world.
 - (i) "**Project**" means a project or activity in relation to which an Applicant submits an Application that directly addresses food insecurity and that aligns with the focus areas set out in the Guidelines; and
 - (j) "**Recipient**" means an Applicant that is successful in being awarded a Grant and has entered into a Funding Agreement with Chobani Australia;
4. Applications will only be considered from organisations which meet the Eligibility Criteria and in compliance with the Grant Webpage, Guidelines and these Terms and Conditions.
5. To be eligible for consideration for a Grant, an Applicant must submit its Application in accordance with the submission instructions, including providing details of the Project and all other requirements set out in these Terms and Conditions, the Guidelines, Grant Webpage and the Application, during the timeframe indicate on the Grant Webpage.
6. Applicants are responsible for the Applications they submit, including its content (such as text, images, photos and videos). Each Applicant warrants that:
 - (a) your Application will not be unlawful, fraudulent or could reasonably be considered to be in breach of any Intellectual Property Rights, privacy, publicity or other rights, defamatory, obscene, derogatory, pornographic, sexually inappropriate, violent, abusive, harassing, threatening, objectionable with respect to race, religion, origin or gender, or otherwise unsuitable for publication;
 - (b) you will obtain prior written consent from any person who is reasonably identifiable in the Application before submitting it;
